In their study of the Assessment of shoreline changes, they have assessed that there is no changes in the shore line due to jetty activities and the report is attached at Annexure-1. 

x)	The wastewater generated shall be treated as per the GPCB norms in the Effluent Treatment plan before letting into creek.	No industrial wastewater is generated due to Jetty operations. However, domestic wastewater (sewage effluent) generated from jetty area is being collected in collection Tank and the same is emptied out periodically in the tanker and treated along with existing domestic sewage treatment plant of KRIBHCO.
xi)	Green belt with appropriate species shall be developed within the project site.	Complied Saplings of different species have been planted in the area.
xii)	The site shall be kept free from pollution by providing suitable drainage system.	Complied KRIBHCO has provided suitable drainage system to keep site free from any pollution.
xiii)	Sewage Treatment Facility shall be provided in accordance with the Coastal Regulation Zone Notification, 1991.	Complied Sewage generated in the jetty area is being collected in a collection pit and transported periodically to existing sewage treatment plant in the KRIBHCO premises for its treatment
