Prospective parties should apply with relevant documents as per criteria along with **Nonrefundable fee of Rs. 590/- (Rs 500 plus GST) per application by way of Demand Draft on nationalized or scheduled bank only drawn in favour of KRIBHCO**, payable at Surat within 30 days of this advertisement.
2. The prospective contractors having any common partners / Directors / Managing Partners etc. or having any business / family, relations or any other common criteria shall be considered as Sister / Group / Associated Company. In such cases, only one of them will be eligible for pre-qualification. The contractors shall indicate which Associate / Concern they intend to get pre-qualified. In case no mention is made about the same, KRIBHCO at its own discretion shall decide, which shall be binding to the contractors.
3. The selection of bidder shall be done based on their past performance highest value turn over on best of last 03 years basis.
4. Bank solvency Certificate by the Nationalized/Scheduled Bank issued on or after the date of press advertisement.
