The job involves annual road transportation of filled “Fertilizer bags” in **sizable volumes from** Hazira plant near Surat / Jetty to various destinations in the state of Gujarat and Maharashtra. Interested transporters are invited to submit their application for pre-qualification with following documents / details:

The transporter who have executed contracts during the last three years i.e. from Jan-2015 to Dec-2017 for transportation of bagged materials like **Fertilizer, Cement, Plastic Granules, Sugar, Food Grains** etc for a single contract having **minimum value of Rs. 25 lakhs in a year** and those having their head office or branch office at Surat or willing to open their office at Surat immediately on award of the contract, only shall be considered for pre-qualification. The transporter should apply with following details & relevant documents along with **Nonrefundable fee of Rs. 2360.00 per application by way of Demand Draft on nationalized or scheduled bank only drawn in favour of KRIBHCO**, payable at Surat within 30 days of this advertisement.

2. Brief History of the firm, type of firm, and organization structure with name of Director / Partners.

5. Bank Solvency Certificate by the Nationalized/Scheduled Bank issued **on or after the date of press advertisement** for a minimum value of Rs.10.0 Lakhs
6. Copy of Audited Annual Report of the firm for last 03 Financial Years 2015-16, 2016-17 & 2017-18.
7. Certificate of Chartered Accountant certifying turnover of firm for the last 3 years i.e. 2015-16, 2016-17 & 2017-18.

10. Details of the **Trucks owned by the transporter in their name along with copies of RC Book and valid Road Permit with pay load capacity issued by RTO Authority.**
11. A Declaration that none of contractors close / distant relatives are working in KRIBHCO. In case any such person is working, details thereof should be clearly indicated and no objection certificate issued by KRIBHCO.
12. A Declaration on company's letter head confirming that Transporter is not blacklisted or banned or put on Holiday list in any public sector undertaking / government undertaking / Govt. Deptt / Central Govt. Financial Institution, court during last 05years.
13. A Declaration on company's letter head that none of group / Associate / Sister Concern has applied for pre-qualification. In case of concealment of any fact, if detected later on, applicant will be debarred from all future dealings with KRIBHCO.
14. The prospective Transporters having any common partners / Directors / Managing Partners etc. or having any business / family, relations or any other common criteria shall be considers as Sister / Group / Associated Company. In such cases, only one of them will be eligible for pre-qualification. The transporters shall indicate which Associate / Concern they intend to get pre-qualified. In case no mention is made about the same, KRIBHCO at its own discretion shall decide, which shall be binding to the transporters.
15. **Transporter may have to acquire digital key from any Government authorized agency for participation in E-tendering through SAP system. Transporter to give confirmation for the same.**
  - Applications received without prescribed fee will not be considered.
  - Applications received after the stipulated date will not be considered.
