DETAILED REQUIREMENTS OF PRE-QUALIFICATION CRITERIA:

The tentative scope of work is attached as Annexure-2. Interested contractors are invited to submit their application for pre-qualification with following documents / details as per criteria:

- Prospective parties should apply with relevant documents as per criteria along with Nonrefundable fee of Rs. 590/- (Rs 500 plus GST) per application by way of Demand Draft on nationalized or scheduled bank only drawn in favour of KRIBHCO, payable at Surat within 30 days of this advertisement.
- 2. Bank Solvency Certificate by the Nationalized/Scheduled Bank issued on or after the date of press advertisement for a minimum value of Rs.10 Lakhs.
- 3. Experience of at least 05 years for running of pharmacy at corporate level or running a pharmacy in a multispecialty hospital having not less than 50 beds or having a chain of outlets of pharmacy." You shall submit the documentary evidence confirming the requisite experience.
- 4. The successful bidder shall maintain the inventory of three months based on consumption pattern.
- 5. The prospective contractors having any common partners / Directors / Managing Partners etc. or having any business / family, relations or any other common criteria shall be considers as Sister / Group / Associated Company. In such cases, only one of them will be eligible for pre-qualification. The contractors shall indicate which Associate / Concern they intend to get pre-qualified. In case no mention is made about the same, KRIBHCO at its own discretion shall decide, which shall be binding to the contractors.

NOTE:

- a) The requirements/ criteria mentioned in Annexure-1 & 2 shall supersede the criteria mentioned elsewhere.
- b) Applications received without prescribed fee and after the stipulated date will not be considered.
- c) The enlistment of Contractors shall be at the entire discretion of KRIBHCO based on objective evaluation of the details regarding past experience, technical and financial competence, and resourcefulness of the Contractors/Firms/Companies.
