A. In First Envelop-

- a) Demand Draft of Rs. 50000/-(Rs Fifty Thousands only) in favour of KRIBHCO Punjab payable at Chandigarh as Earnest Money (EMD).
- b) Photocopy of valid Licence, TIN No. and GST No.
- c) Signature on each page of attached Terms and conditions Performa.
