

TWO BID SYSTEMS

Two independent sealed envelopes should be prepared as detailed below: •

• ENVELOPE NO.1 (SEALED)


This envelope should be marked as 'ENVELOPE NO.1 – TECHNICAL BID FOR DISPOSAL OF SOYBEAN GRAINS and should contain in Part "A" (Technical Bid) with covering letter on letter head (Tenderer should invariably mention their name, address, Mobile No., etc. on left hand side of envelope for clear identification).

• ENVELOPE NO.2 (SEALED)

This envelope should be marked as 'ENVELOPE NO.2- FINANCIAL BID FOR DISPOSAL OF SOYABEAN GRAINS' and should contain in PART "B" (Financial Bid) (Tenderer should invariably mention their Name, Address, Mobile No., etc. on left hand side of envelope for clear identification). •

• Both the envelopes should be placed in one big sealed envelope super scribing "BID OF TENDER FOR DISPOSAL OF SOYBEAN GRAINS" The sealed bids should be delivered in the office of the Sr. Area Manager- Seed , KRIBHCO, Plot No.47-48-53-54, MPAKVN Industrial Area, A.B. DETAILED TERMS & CONDITIONS OF THE TENDER FOR THE DISPOSAL OF SOYBEAN GRAINS

1. The stock(s) available for the sale are to be disposed off on "AS IS & WHERE IS BASIS".
2. The stock is available for inspection by the parties between 11:00 AM & 4:30 PM on any working day at the concerned stocking places. They may contact Sr. Area Manager (Seed) Dewas (Mobile. No. 9425301373), Agar Malwa (Mobile. No. 9425301382) & Manager Marketing, Ratlam (Mobile. No. 9425301376) of the concerned Offices.
3. If Tenderer downloaded tender forms from KRIBHCO site than submit draft of Rs.100/- drawn in favour of KRISHAK BHARATI CO-OPERATIVE LIMITED. Payable at Bhopal in envelop No.1 (Part A – Technical Bid)
4. Tender should be accompanied by Earnest Money Rs. 2,50,000/- in the form of Demand Draft drawn in favour of KRIBHCO BHOPAL , payable at Bhopal. Tender will not be accepted without EMD and tender form fee. EMD through Cheque will not be entertained in any case.
5. While lifting the Soybean Grain , the tenderer will have to arrange their own bags, the empty begs of Kribhco will be deposited at lifting warehouse.
6. The arrangements for lifting the soybean grain will be made by the Tenderer at his own cost after finalization of disposal rate by KRIBHCO.
7. The stocks will be supplied after removing the labels/ tags and defacing the bags on "as is & where is basis"
8. The successful Tender will have to lift the stock within 15 days from the date of issue of he award of tender or issue of the order whichever is earlier. The Tenderer shall be liable to deposit full payment/cost of soybean grains to KRIBHCO before lifting it within 15 days as aforesaid failing which KRIBHCO shall stop the delivery of the soybean grains and shall have discretion to terminate the award of the tender given in favour of the tender without any liability of KRIBHCO. In addition, KRIBHCO shall forfeit the full amount of earnest money and the party will be blacklisted and shall have no claim on the soybean grains.
9. The successful tenderers will have to pay all legal taxes, such as GST, Mandi Tax or any other tax as may be applicable at the time of actual lifting of stock in addition to the rates offered / accepted.
10. No interest will be paid on the EMD and the same will be refunded only after lifting of the entire stocks without any interest to the successful tenderers. EMD will not be adjusted against the cost of the stock. However, EMD will be refunded to the un- successful tenderers within 30 days.

11. The tender should be submitted only after agreeing with all the terms & conditions and the conditional tenders will not be entertained.
12. The tenderer has to quote for the entire quantity as a whole and not in part and rate should be quoted per Qtls. basis as the case may be.
13. The tenders are required to be submit price bid as mentioned in NIT of KRIBHCO.
14. The KRIBHCO will not undertake re-cleaning of the soybean grains under any circumstances and the parties have to lift the stock "AS IS & WHERE IS BASIS".
15. The employees of the KRIBHCO and the members of their family are not entitled to participate in the tender directly or indirectly.
16. Any difference or dispute arising out of or in connection with the tender or any provision herein shall be referred for an arbitration by a sole arbitrator as may be appointed by the Managing Director-KRIBHCO, in accordance with the provision of the Indian Arbitration & conciliation Act 1996 or any statutory modification or reenactment thereof. Such arbitration shall be held at Noida only and the proceeding shall be held in English language.

"Subject to the the Arbitration clause herein above, the Court at Noida shall have exclusive jurisdiction to adjudicate upon the dispute arising in relation to this agreement between the parties"
17. KRIBHCO shall not be liable for any third party claim; suit or liability of any nature wich may arise in connection with the soybean grain sold to any Tenderer under this agreement & use thereof by the Tenderer of any purpose whatsoever.
18. KRIBHCO represents no warranty to the Tenderer for the fitness of the stock for any particular purpose or fetches any particular result to the Tenderer, as may have been intended by the Tenderer. Also KRIBHCO shall not be liable for any suit, loss damage claim, recovery etc in connection therewith.
19. Any failure or default in supply of the product by KRIBHCO shall not give rise to any claim for damage against KRIBHCO if caused by Force Majeure i.e. of matters beyond the reasonable control of KRIBHCO including but not limited to act of God, act of Government authorities, strike or other concerted act of workmen, riots, floods, explosions breakdown of plant civil commotion etc.
20. In case of delay in lifting of Soybean Grain / stores, any loss on account of storage charges from the date of communication of the acceptance will also be recovered & Penalty for delay in unsold seed lifting per week 1% maximum of 5% of value of work.
21. The KRIBHCO is not bound to accept the highest quotation. Any or all the quotations may be rejected without assigning any reason thereof. The KRIBHCO also reserves the right to accept in whole or part of the offers made. The decision of the KRIBHCO in this matter shall be final and binding.
