INTRODUCTION:

KRIBHCO operates Natural gas (NG) based Fertilizer Plant comprising two streams of Ammonia, four streams of Urea, Power Plant, Product Handling Plant and other Offsite plants based at Hazira, Surat, Gujarat.

KRIBHCO owns and operates a private jetty at Hazira, with a permission of GMB to handle upto 46.60 Lakh MT of cargo annually. The Jetty is currently operational and has competitive advantage of rail/road link for faster evacuation.

At present KRIBHCO has permission for Use of jetty for handling of Bulk cargo of fertilizers or de-oiled cake or other dry bulk cargo like gypsum or slag or Agri products or sugar or food grains or MOP or clinker or rock phosphate or cement in bulk and bags or construction materials or lime stone or iron ore or Bentonite or aggregate stone or bauxite or coal or pet coke in cargo mix or non-hazardous liquid cargo like molasses.

LOCATION:

The jetty is a part of Magdalla port situated in Tapi estuary and it is located at latitude 21^o 08 North and longitude 72^o 42 East. Magdalla is a lighterage port and the anchorage is about 15 NM southwest.

FACILITIES:

- a. The size of existing wharf is 147-meter-long and 40-meter-wide with monolithic wall type construction. The top level is + 6.5 meter. There is also a ramp of 72.5-meter-long and 20-meter-wide on east of the wharf.
- b. The distance between KRIBHCO jetty and National Highway No. 06 (Near Kawas) is approximately 6 KM. Nearest railway platform of KRIBHCO railway siding is approximately 2.5 KM approx.
- c. To facilitate berthing of barges at Jetty, dredging operations are to be carried out as and when required near the pocket size of approximate 180-meter X 80-meter X 6.5 meter.
- d. Paved area of wharf near the quay wall size about 147-meter X 40 meter is paved in concrete with light reinforcement.
- e. Parking area for the dumpers, pay-loader, cranes etc are available at jetty.
- f. Uninterrupted power supply from 11 KV feeders at KRIBHCO power plant has been extended to meet the power requirements.
- g. Suitable firefighting system, water supply and drainage, sewage disposal and fencing are available.
- h. KRIBHCO Jetty is a fair weather and tidal Jetty, movement of barges is to be carried out with GMB permission during monsoon.
- i. Open plot of land on "as is where is basis", will be made available to successful bidder for cargo storage, parking of vehicles (pay loaders, dumpers etc. required for cargo handling. However, party will develop such land on their own cost suiting the needs of the cargo to be handled by them.
