### **3.0 DEFINATIONS:-**

**3.1** KRIBHCO shall mean **KRISHAK BHARATI COOPERATIVE LIMITED.**

**3.2** Material shall mean c class bags of KRIBHCO seeds.

**3.3** Contract Order means the contract arising out of the acceptance of tender by KRIBHCO for the said purpose

**3.4** Party means the successful tendered whose tender is acceptance to Kribhco.

**3.5** Bags mean c class bags of 50 kg Jute capacity used for seeds.

**4.0** EMD demand draft of Rs 10000/- in favour of Krishak Bharati Cooperative Limited Haryana Payable at Chandigarh issued from Nationalized/schedule/Co -Operative bank.

**5.0** Contract order shall come in force on the date of which KRIBHCO sends its acceptance to the party.

**6.0** Not with standing anything to the contrary contained in tender notice issued the contract order shall be governed entirely by the terms & conditions here in stipulated.

**7.0** The party has to lift the entire c class bags as per the tender. KRIBHCO may however, discretion extend the period of contract.

**8.0** The rates for lifting of c class bags are to be charged on the basis of tender notice accepted.

**9.0** The rates quoted in the tender shall be exclusive of all taxes etc. Rates will be quoted net rate for per bag and shall be valid for 90 days. S Tax & VAT if any will be born by the party.

**10.0** The release order will be issued to the party on receipt of payment in advance in the shape of Demand draft/ RTGS/ NEFT payable in the name Krishak Bharati Cooperative Limited Haryana (Chandigarh). The party has to deposit entire amount of quantity mentioned in the tender notice.

**11.0** The validity of release order of lifting of c class bags will be 30 days from the date of issue of R.O.

**12.0** The lifting by the party will be done on Ex-warehouse basis & no handling and transportation cost there on shall be born by KRIBHCO.

**13.0** The stocks will be lifted as & where basis without permission of segregation.

**14.0** The c class bags shall be defaced before further using.

**15.0** In case of breach of any of the terms & conditions by the party the EMD/Security can be forfeited & contract can be terminated.

**16.0** In case of any dispute arising out during the contract periods the matter will be referred to the Managing Director Kribhco who shall act sole arbitrator & his decision will be final and binding on both the parties.

**17.0** The terms & conditions and subject to force major clause default in the performance by the party shall be considered

**18.0** Conditional tender will be rejected & the party will certify & declare that none of my/our group/ Associates/sister concerned is participated in the tender never banned /black listed by any financial Institutions/ court for participating in the tender.
