**NOTICE INVITING APPLICATIONS FOR PRE-QUALIFICATION OF CONTRACTORS FOR BAGGING AND HANDLING OF UREA:**

Krishak Bharati Cooperative Ltd., (KRIBHCO), a fertilizer manufacturing unit located near Hazira in Surat District (Gujarat) intends to pre-qualify contractors for Bagging and Handling of Urea.

The job involves filling of Urea in bags, stitching, loading of bags in Trucks/Wagons, stacking/de-stacking of bags, unloading empty bags from trucks and stacking etc. Interested contractors are invited to submit their application for pre-qualification with following documents / details:

The contractors who have executed contracts for Bagging and Handling of Fertilizer/ Cement/ Plastic granules during the last five years i.e. from Jan-2016 to Dec-2020 and executed at least a single contract having either minimum order value of Rs 200.00 Lakhs or minimum quantity of 12 Lakhs MT in a year. Copies of completed Work Orders executed and performance certificates issued thereof for satisfactory completion of the work under the same work order from the clients and those having their head office or branch office at Surat or willing to open their office at Surat immediately on award of the contract, only shall be considered for pre-qualification

The transporter should apply with following details & relevant documents along with **Nonrefundable fee of Rs. 2360.00 per application by way of Demand Draft on nationalized or scheduled bank only drawn in favour of KRIBHCO**, payable at Surat within 30 days of this advertisement.

2. Brief History of the firm, type of firm, and organization structure with name of Director / Partners.
3. Copies of Registration of the firm, Partnership deed or Memorandum and Article of Association or Bylaws & authorization letter for the signatory.
4. Copy of Income Tax Return for **last 03 Assessment years** i.e. 2018-19, 2019-20 and 2020-21.
5. Bank Solvency Certificate by the Nationalized/Scheduled Bank issued **on or after the date of press advertisement** for a minimum value of Rs.50.0 Lakhs
6. Copy of Audited Annual Report of the firm for last 03 Financial Years 2017-18, 2018-19, 2019-20.
7. Copy of Permanent Account No. (PAN) issued by Income Tax Department, GST Reg No, PF Code No issued by RPF, ESI code No issued by competent authority.
- 8.0 Copies of completed / executed Work Orders [with all details] during last 05 [Five] years i.e. from Jan 2016 to Dec 2020 and Performance Certificates issued thereof for satisfactory completion / performance of the work under the same work orders from clients. The contractors who have successfully executed a single contract for Bagging and Handling of Fertilizer / Cement / Plastic granules having either minimum quantity of 12 lakhs metric tons or minimum order value of Rs.200 lakhs, in a single year during last five years shall only be considered for Pre-qualification.

9. A Declaration on company's letter head that none of contractors close / distant relatives are working in KRIBHCO. In case any such person is working, details thereof should be clearly indicated and no objection certificate issued by KRIBHCO.
  10. A Declaration on company's letter head confirming that contractor is not blacklisted or banned or put on Holiday list in any public sector undertaking / government undertaking / Govt. Deptt / Central Govt. Financial Institution, court during last 05 years.
  12. A Declaration on company's letter head that none of group / Associate / Sister Concern has applied for pre-qualification. In case of concealment of any fact, if detected later on, applicant will be debarred from all future dealings with KRIBHCO.
  13. The prospective contractors having any common partners / Directors / Managing Partners etc. or having any business / family, relations or any other common criteria shall be considers as Sister / Group / Associated Company. In such cases, only one of them will be eligible for pre-qualification. The contractors shall indicate which Associate / Concern they intend to get pre-qualified. In case no mention is made about the same, KRIBHCO at its own discretion shall decide, which shall be binding to the contractors.
