NOTICE INVITING APPLICATIONS FOR PRE-QUALIFICATION OF MANUFACTURERS FOR SUPPLY OF PP THREAD:

Krishak Bharati Cooperative Ltd., (KRIBHCO), a fertilizer manufacturing unit located near Hazira in Surat District (Gujarat) intends to pre-qualify **Manufacturer**/ **Authorized Distributor/Dealer** for supply of PP thread used for packing of Urea Bags. In case of dealer/distributor, valid authorization letter from manufacturer is required.

DETAILED REQUIREMENTS OF PRE-QUALIFICATION CRITERIA:

The supplier should have their own manufacturing unit with annual capacity of manufacturing of 24,000 Kgs. of PP Thread OR supplied at least above qty. in a year.

The job involves supply of PP Thread on Annual Rate Contract Basis with specifications as under:

A) Technical Specifications

- High tenacity polypropylene multi-filament twisted bag closing thread with heat set.
- Denier: 1200+/-5%
- Construction: 210d / 3 x 2
- Basic yarn denier: 210d +/-5%
- Breaking strength: 6 kg & above.
- Packing size: 1 kg in jumbo cardboard cones with plastic disc insertion inside. The conical cone shall be laminated top 1-2 inch for smooth unwinding. 1-inch portion of top & bottom of cone shall be left blank. (Refer Picture below)
- Colour: White.
- Renege: 7150 Mtr / kg
- Ply twist: 280 TPM s-ways.
- Cable twist: 240 TPM z-way

B) Technical Compliance

- The suppler has to submit third party test certificate for each lot which would be supplied against a particular purchase order placed upon them.
- The Testing: will be done as per **IS 12734:2002** and other associated Indian standard applicable for the same, parameters will be tested for acceptance for the following:
 - i. denier: 1200+/- 5%
 - ii. Breaking load: > 6kgf.
- The supplier should submit Factory license and Capacity certificate (issued by competent authority or CA)
- Each cone is to be wrapped with transparent paper. Name of the manufacture shall be embossed on the transparent paper, in case if it is not embossed, plane transparent paper shall be used and a separate sticker shall be placed on the cone, which shall be easily readable.
- Thread must be supplied in standard cones/spools with suitable packaging for transport.
- The buyer reserves the right to inspect the manufacturing unit and conduct pre-dispatch testing.

• The material will be accepted only after receipt of test certificate & satisfactory result of laboratory test carried out at KRIBHCO.

The suppliers who have supplied PP Thread under single Purchase Order during the last five years i.e. from 01.08.2020 to 31.07.2025, having supplied minimum quantity of 24,000.00 Kgs. of PP Thread in one year, only shall be considered for pre-qualification.

The suppliers should apply with following details & relevant documents along with Nonrefundable fee of Rs.2,360.00 (Rs. 2000.00 + GST @18%) per application by way of Demand Draft on nationalized or scheduled bank only drawn in favour of KRIBHCO, payable at Surat within 30 days of this advertisement.
