  - 10.0** The Supplier should be manufacturer of Neem oil and submit the requisite document to fulfil these criteria (The dealer or trader of Neem oil shall not considered).
  - 11.0 A Declaration on company's letter head that none of contractors close / distant relatives are working in KRIBHCO. In case any such person is working, details thereof should be clearly indicated and no objection certificate issued by KRIBHCO.
  - 12.0 A Declaration on company's letter head confirming that contractor is not blacklisted or banned or put on Holiday list in any public sector undertaking / government undertaking / Govt. Deptt / Central Govt. Financial Institution, court during last 05 years.
  - 13.0 A Declaration on company's letter head that none of group / Associate / Sister Concern has applied for pre-qualification. In case of concealment of any fact, if detected later on, applicant will be debarred from all future dealings with KRIBHCO.
  - 14.0 The prospective manufacturers having any common partners / Directors / Managing Partners etc. or having any business / family, relations or any other common criteria shall be considers as Sister / Group / Associated Company. In such cases, only one of them will be eligible for pre-qualification. The contractors shall indicate which Associate / Concern they intend to get pre-qualified. In case no mention is made about the same, KRIBHCO at its own discretion shall decide, which shall be binding to the suppliers.
- Applications received without prescribed fee will not be considered.
