NOTICE INVITING APPLICATIONS FOR PRE-QUALIFICATION OF SUPPLIERS FOR SUPPLY OF LIQUID NITROGEN:

Krishak Bharati Cooperative Ltd., (KRIBHCO), a fertilizer manufacturing unit located near Hazira in Surat District (Gujarat) intends to pre-qualify **Suppliers for Supply of Liquid Nitrogen.**

DETAILED REQUIREMENTS OF PRE-QUALIFICATION CRITERIA:

The job involves supply of Liquid Nitrogen on Annual Rate Contract Basis with specification as under:

Liquid Nitrogen in Tankers.

Nitrogen Gas having purity 99.999% or higher and oxygen less than 5 ppm in Road Tankers

The Suppliers who have supplied Liquid Nitrogen under single Purchase Order during the last five years i.e. from Jan - 2016 to Dec - 2020, having supplied minimum quantity of 55,000 SM³ and capacity to supply more than 2,20,000 SM³ of Liquid Nitrogen in one year only shall be considered for pre-qualification. The suppliers should apply with following details and relevant documents;

The Suppliers should apply with following details & relevant documents along with **Nonrefundable fee of Rs. 590.00 (Rs. 500 + 18% GST) per application by way of Demand Draft on nationalized or scheduled bank only drawn in favour of KRIBHCO,** payable at Surat within 30 days of this advertisement.

2. Brief History of the firm, type of firm, and organization structure with name of Director / Partners.
3. Copies of Registration of the firm, Partnership deed or Memorandum and Article of Association or Bylaws & authorization letter for the signatory.
4. Copy of Income Tax Return for **last 03 Assessment years** i.e. 2018-19, 2019-20 and 2020-21.
5. Bank Solvency Certificate by the Nationalized/Scheduled Bank issued **on or after the date of press advertisement** for a minimum value of Rs.10.00 Lakhs
6. Copy of Audited Annual Report of the firm for last 03 Financial Years 2017-18, 2018-19, 2019-20.
7. Copy of Permanent Account No. (PAN) issued by Income Tax Department and GST Reg No.
8. EFT Details as per attached Format with a copy of cancelled cheque.

Copies of completed / executed Purchase Orders [with all details] during last 05 [Five] years i.e. from Jan - 2016 to Dec - 2020 and Performance Certificates thereof issued for satisfactory completion/ performance of the supply under the same PO from clients. The suppliers who have successfully supplied minimum quantity of 55,000 SM³ of Liquid Nitrogen under single PO and have capacity to supply more than 2,20,000 SM³ in a single year during last five years and having either manufacturing certificate or tie-up certificate with a manufacturer shall only be considered for Pre-qualification.**
 10. Tie - up certificate from manufacturer, if supplier is not manufacturer of Liquid Nitrogen.
 11. A Declaration on company's letter head that none of the close / distant relatives of supplier are working in KRIBHCO. In case any such person is working, details thereof should be clearly indicated and no objection certificate issued by KRIBHCO.
 12. A Declaration on company's letter head confirming that supplier is not blacklisted or banned or put on Holiday list in any public sector undertaking / government undertaking / Govt. Dept. / Central Govt. Financial Institution, court during last 05 years.
 13. A Declaration on company's letter head that none of group / Associate / Sister Concern has applied for pre-qualification. In case of concealment of any fact, if detected later on, applicant will be debarred from all future dealings with KRIBHCO.
 14. The prospective Suppliers having any common partners / Directors / Managing Partners etc. or having any business / family, relations or any other common criteria shall be considered as Sister / Group / Associated Company. In such cases, only one of them will be eligible for pre-qualification. The suppliers shall indicate which Associate / Concern they intend to get pre-qualified. In case no mention is made about the same, KRIBHCO at its own discretion shall decide, which shall be binding to the suppliers.
- Applications received without prescribed fee will not be considered.
 - Applications received after the stipulated date will not be considered.
