- 1. <u>INTRODUCTION</u>: -Bio-Fertilizer is a perishable manure and contain microorganisms and has got its own shell life, so it is to be used within its expiry date. - 2. Scope of work of this contract is transportation of Bio fertilisers to various destinations all over India. The work consists of supplying road worthy tempos/ mini truck/ tempos at Kribhco's project site at Hazira collecting and delivering the consignments of Bio fertilisers to various destinations. Destination wise/ slab wise requirements are indicative and actual requirement may vary substantially.
