Criteria of New Vendor Registration for procurement of Bulk Chemicals for Bio Fertilizer Production:

1. Vendor shall be a manufacturer or an authorized dealer/ trader.
2. In case of authorized dealer/ trader, vendor has to submit the authorization certificate obtained from the manufacturer along with other supporting documents i.e., notarized declaration regarding authentication of authorization.
3. If the vendor is an authorized dealer/ trader, they should have supplied the chemicals of AR/ LR grade manufactured by the known manufacturer.
4. Vendor should produce the copy of Purchase Orders of chemicals supplied to the industries manufacturing Bio Fertilizers/ other bacterial product. (List of chemicals as above)
5. Vendor have to produce quality certificate of chemicals for each individual batch along with their delivery.
6. Date of manufacturing should not be older than two months than the date of delivery.
7. Vendor shall be capable of supplying the chemicals with minimum quantity of 5000 Kg in a single lot considering minimum order value of Rs. 25,00,000.00 and annual turnover shall be minimum Rs. 2,50,00,000.00 within the stipulated time given in Purchase Order

12. A Declaration on company's letter head that none of group / Associate / Sister Concern has applied for pre-qualification. In case of concealment of any fact, if detected later on, applicant will be debarred from all future dealings with KRIBHCO.

The prospective Suppliers having any common partners / Directors / Managing Partners etc. or having any business / family, relations or any other common criteria shall be considered as Sister / Group / Associated Company. In such cases, only one of them will be eligible for pre-qualification. The suppliers shall indicate which Associate / Concern they intend to get pre-qualified. In case no mention is made about the same, KRIBHCO at its own discretion shall decide, which shall be binding to the suppliers.
