**DETAILED REQUIREMENTS OF PRE-QUALIFICATION CRITERIA:**

**Technical Eligibility criteria:**

**1. Technical Capability**

The party shall **own and/or have firm deployment control** over a minimum of **Twelve (12) hydro jet cleaning machines**.

Each hydro jet machine shall meet the following minimum specifications:

- Operating pressure of machines which can develop minimum pressure of 800 bar.
- Equipped with **single/double lance facility** suitable for tube cleaning.
- Machine shall be in **sound working condition**, with maintenance records available for verification.
