KRISHAK BHARATI COOPERATIVE LIMITED (KRIBHCO) hereinafter referred as KRIBHCO is a premier National level Cooperative Society of India engaged in fertilizer production and distribution and is registered under Multi State Cooperative Societies (MSCS) Act, 2002. KRIBHCO Seed Unit Dewas is inviting tender for Wheat grain (Fail seed) sale.

A. Terms & Conditions: -

- 1. The stock available for the sale are to be disposed of on "AS IS & WHERE IS BASIS".
- 2. The quantity of wheat grain (Fail seed) for sale is 163.20 quintals.
- 3. The stock is available for inspection by the parties between 11:00 AM & 4:30 PM till date 27.01.2025 on any working day at the concerned stocking places. They may contact Plant In-charge SPU Dewas (Mobile. No. 8370001097).
- 4. The Tenderers shall have the following document (Self Verified photocopy) to be provided in the Technical Bid.
 - I. Valid trade license certificate.
 - II. Regular GST Registration Certificate
 - III. PAN No. Registration Certificate
 - IV. Registration under shop and establishment.
- 5. Tenderers should be accompanied by Earnest Money Rs. 25,000/- in the form of Demand Draft drawn in favor of ''KRISHAK BHARATI COOPERATIVE LIMITED'', payable at Bhopal Or the tenderer can also deposit the EMD in KRIBHCO bank account by RTGS/NEFT by 5.30 PM on 27.01.2025. Tenderer is required to provide DD or UTR number of RTGS / NEFT of Earnest Money Deposit in the Technical Bid. Tender will not be accepted without EMD. EMD through Cheque will not be entertained in any case.

- 6. While lifting the wheat Sub Standard (Fail Seed) Grain the tenderer will have to arrange their own bags, the empty bags of KRIBHCO will be deposited at lifting warehouse.
- 7. The arrangements for lifting the Wheat Sub Standard (Fail Seed) Grain will be made by the Tenderer at his own cost after finalization of disposal rate by KRIBHCO.
- 8. The successful Tender will have to lift the stock within 30 days from the date of issue of the award of tender or issue of the order whichever is earlier. The Tenderer shall be liable to deposit full payment/cost of Wheat Sub Standard Seed (Wheat grain) to KRIBHCO before lifting it within 30 days as aforesaid failing which KRIBHCO shall stop the delivery of the Wheat grains and shall have discretion to terminate the award of the tender given in favor of the tender without any liability of KRIBHCO. In addition, KRIBHCO shall forfeit the full amount of earnest money and the party will be blacklisted and shall have no claim on the Wheat grains.
- 9. The successful tenderers will have to pay all legal taxes, such as GST, Mandi Tax or any other tax as may be applicable at the time of actual lifting of stock in addition to the rates offered / accepted.
- 10. No interest will be paid on the EMD and the same will be refunded only after lifting of the entire stocks without any interest to the successful tenderers. EMD will not be adjusted against the cost of the stock. However, EMD will be refunded to the un-successful tenderers within 30 days.



- 11. The Tenderers should be submitted only after agreeing with all the terms & conditions and the conditional tenders will not be entertained.
- 12. The tenderer has to quote for the entire quantity as a whole and not in part and rate should be quoted per Qtls. basis as the case may be.
- 13. The Tenderers are required to be submit price bid as mentioned in Annexure-B.
- 14. The KRIBHCO will not undertake re-cleaning of the Wheat grains under any circumstances and the parties have to lift the stock "AS IS & WHERE IS BASIS".
- 15. The employees of the KRIBHCO and the members of their family are not entitled to participate in the tender directly or indirectly.
- 16. Any difference or dispute arising out of or in connection with the tender or any provision herein shall be referred for an arbitration by a sole arbitrator as may be appointed by the Managing Director-KRIBHCO, in accordance with the provision of the Indian Arbitration & conciliation Act 1996 or any statuary modification or reenactment thereof. Such arbitration shall be held at Noida only and the proceeding shall be held in English language.

"Subject to the Arbitration clause herein above, the Court at Noida shall have exclusive jurisdiction to adjudicate upon the dispute arising in relation to this agreement between the parties"

- 17. KRIBHCO shall not be liable for any third party claim; suit or liability of any nature which may arise in connection with the Wheat grain sold to any tenderer under this agreement & use thereof by the Tenderer of any purpose whatsoever.
- 18. KRIBHCO represents no warranty to the Tenderer for the fitness of the stock for any particular purpose or fetches any particular result to the Tenderer, as may have been intended by the Tenderer. Also KRIBHCO shall not be liable for any suit, loss damage claim, recovery etc. in connection therewith.
- 19. Any failure or default in supply of the product by KRIBHCO shall not give rise to any claim for damage against KRIBHCO if caused by Force Majeure i.e. of matters beyond the reasonable control of KRIBHCO including but not limited to act of God, act of Government authorities, strike or other concerted act of workmen, riots, floods, explosions breakdown of plant civil commotion etc.
- 20. In case of delay in lifting of Wheat Sub Standard (Fail Seed) Grain stores, any loss on account of storage charges from the date of communication of the acceptance will also be recovered & Penalty for delay in unsold seed lifting per week 1% maximum of 5% of value of work.
- 21. The KRIBHCO is not bound to accept the highest quotation. Any or all the quotations may be rejected without assigning any reason thereof. The KRIBHCO also reserves the right to accept in whole or part of the offers made. The decision of the KRIBHCO in this matter shall be final and binding.
- 22. Quantity of Wheat Sub Standard (Fail Seed) Grain mentioned in the tender notice may vary up to 05% (approx.) at the time of delivery. Tenderer should make proper weighment before lifting of stock in presence of the KRIBHCO representative. The excess amount deposited due to difference in Quantity lifted and the tender quantity will be adjusted later on after request letter of the party along with EMD refund. KRIBHCO will not be responsible for any shortage in Qty. after lifting of the stock. Wheat Sub Standard (Fail Seed) Grain (163.20 Qtl) available at Seed Processing Unit Dewas.
- 23. The rate quoted will be valid up to 90 days.

- b. Envelope No.-2 Annexure-B should be filled in with the rates in numbers and words in clear letters, signed and sealed. Write "FINANCIAL BID" on the envelope in clear letters and the tenderer should also write the name of his firm.
- c. Envelope No.-3 Envelope No.1 and Envelope No.2 should be kept in Envelope No.3 and sealed. On the envelope, write "TENDER FOR SALE OF WHEAT GRAIN (FAIL SEED)" in clear letters and the tenderer should also write the name of his firm, which should be made payable in the name of Area Manager.
- 8. All tenders will be opened on the date and time fixed by the constituted committee. All tenderers can participate in the tender process either in person or with their authorized representatives. If for any reason any tenderer or his representative is not present, then it will not be considered by the committee.
- 9. Envelope No. 1 kept in Envelope No. 3 will be opened first by the committee. If all the documents found in Envelope No. 1 do not fulfill the eligibility criteria as per the rules, then Envelope No. 2 containing the tender rate form submitted by the concerned tenderer will not be opened.
